

HISTORY

Named from a slogan coined by the media in the early 1970s, Jews for Jesus was officially founded in 1973 by Dr. Moishe Rosen. In the following decades, what was first a small cadre of Jewish believers in Jesus dedicated to reaching out with the good news of the Messiah in their community grew to become a global ministry in 13 countries and 25 cities around the world.

Under the leadership of David Brickner, Jews for Jesus continues to expand and spread the message of Jesus as Messiah to people worldwide. The organization currently serves cities in North America, Europe, South Africa, Australia, and Israel, with its largest branch by personnel located in the trendy Florentine neighborhood of Tel Aviv. Jews for Jesus embraces new, creative modes of ministry to communicate the message of Jesus as Messiah. The Jews for Jesus staff and corps of volunteers spans multiple generations including Boomers and Millennials, all passionate about making Jesus' messiahship known. 

THE OPPORTUNITY

Overview:

The **Chief Financial Officer (CFO)** reports to and partners with the Executive Director to provide overall vision for financial policy of Jews for Jesus, establish financial and operational strategy, and lead all aspects of financial administration, business planning, risk management, budgeting, and reporting. The CFO will provide financial thought leadership as an integral member of the Executive Leadership Team (ELT), which consists of nine global leaders who collaboratively provide strategy to the organization. Most importantly, the CFO will ensure the integrity of the ministry's fiscal accountability and stewardship.

Responsibilities:

STRATEGY

- Articulate, develop, and implement ministry-wide strategic business plans in collaboration with the ELT.
- Lend guidance to the strategic planning process and provide recommendations based on thorough financial analysis.
- Align operational management with short- and long-term financial planning and projections.

OPERATIONAL LEADERSHIP

- Lead managers of these areas: Office Management, Finance, Human Resources (HR), Information Technology & Security (IT), Data Entry (DRUM), Church Relations (DOME), Facilities, Project Management, General Legal Counsel, and Executive Assistant/Donor Relations.
- Strengthen all business procedures, processes, and administration by identifying opportunities for improvements and innovation that result in greater operational efficiencies.



RISK MANAGEMENT

- Ensure compliance with all legal and regulatory requirements, including maintaining appropriate insurance coverage, record-keeping in accordance with GAAP, and reporting risk issues to the AFI Committee and Board.
- Maintain relations with external auditors, coordinate all audit activities, and investigate their findings and recommendations.
- Cooperate with General Legal Counsel to monitor all open legal issues involving Jews for Jesus and any other broader issues or pending regulations that may affect the organization.

FINANCIAL MANAGEMENT

- Govern budget planning/implementation and investment management, monitoring progress and use of funds to ensure sound stewardship of resources and budget compliance.
- Develop and monitor key financial and operational metrics to assess performance; Prepare and communicate financial statements, forecasts, and reports, including presenting to the Board three times/year.
- Ensure that adequate funds exist to meet financial obligations and plan for capital expenditures; develop strategies for managing cash reserves.

Key Characteristics:

As a key executive within the organization, the **Chief Financial Officer** should be an experienced, confident leader and strong team builder with a mature faith in Jesus as Messiah and Savior. The CFO must be committed to the professional development of his/her staff. He/she must understand and commit to the purposes of Jews for Jesus, including signing the Doctrinal Statement. The candidate must also lead a lifestyle which actively reflects his/her commitment to honor God and uphold the Jews for Jesus mission and culture.

Qualifications:

- A minimum of a B.S. in Finance, Business or Accounting. Preference will be given to candidates with an MBA in Finance or CPA/CMA designations.
- At least ten years of experience, with progressively responsible roles in accounting or financial leadership; advanced competencies in financial analysis and management.
- Minimum of three years of executive leadership experience as a CFO or equivalent.
- Demonstrated ability to lead people and processes.
- Demonstrated ability to build relationships with people.
- Proven experience in strategically and directly supporting the CEO and Board.
- Experience with vision casting, strategic planning and team building.
